 - b. Other criminal activity reports will be considered on a case by case basis by the Application Committee, and then by the Board of Directors.
4. Upon approval, you will be contacted for an interview with an Application Committee member.
5. Upon approval, your application shall be submitted to Board of Directors for review.
6. Upon approval, your application shall be voted upon for final approval from the general membership.
